Abstract

This Report contains the details of the activities and achievements of Higher Education Commission Regional Centre Quetta accomplished during the session 2009-10. The Report discusses the details in terms of the Responsibilities and duties assigned to the Regional Centre.

This Report comprises of five sections which are following

- 1. Administrative Duties
- 2. Academic Duties
- 3. Duties as Public Relations Officer
- 4. Duties in Relations to Students and Teacher Welfare
- 5. Duties as Liaison Office

Each task is placed under these categories depending on the nature of the task accomplished. Administrative duties contain activities like Office Establishment, Material Distribution, Data Collection, Test/Interviews of Candidates, and Court cases. Academic duties contain Project FATA-Balochistan and organizing of Events and Occasions. Meetings are the part of Duties as Public Relations Officers. Intra and Extra Curriculum activities arranged by the Regional Centre are place under the duties in Relations to Students and Teacher Welfare. Duties as Liaison Office comprises of activities like Attestation and Accreditation, Press Releases and development of Webpage for Regional Centre Quetta.

HEC Regional Centre Quetta after its establishment faced many problems in performing these duties in the region. Though it was a tough situation for a newly established office somehow overall outcome from the centre was quite optimistic. The Centre is still under the construction phase and it is expected to have a better future ahead of it.

Introduction

The Higher Education Commission Regional Centre Quetta was established by the Higher Education Commission in 3rd May 2009 to facilitate the activities of HEC in the Region. As per Notification of the HEC Islamabad, The centre was required to undertake following work/Duties:

1. Administrative Duties

- a. To maintain the Regional Office in Quetta
- b. To distribute reading materials, journals, newsletters, library materials etc. to Universities in the Region.
- c. Generally to assist in promoting the activities of the HEC in such manner as may be determined.

2. Academic Duties

- a. To make arrangements for holding workshops, Colloquia, Seminars, Lectures, Conferences etc.
- b. To organize Extension Lectures at Universities
- c. To supervise and help in the implementation of HEC Projects and activities in the Universities of the Region.
- d. To coordinate HEC program in Degree awarding institutions and Universities in the Region.
- e. Organize teacher training courses for teachers in Universities and Degree awarding institutions.

3. Duties as Public Relations Officer

- a. To act as reception office for visiting teachers, Scholars, Students and Foreign Delegates.
- b. To organize meetings in the Regional Office or in a University.
- c. To assist in projecting achievement of Universities

4. Duties in Relations to Students and Teacher Welfare

- a. To guide and assist students and teachers in the Universities at Quetta in solving their difficulties and smooth relationship amongst them and with the Universities.
- b. To organize Intra and Extra-Curricular activities in the Universities/ Degree Awarding Institutes in the Region or on behalf of HEC in other Regions.
- c. To organize Sports activities in the Region.

5. Duties as Advisor Foreign Students

- a. Organize, Supervise and promote foreign Students Advisory Services in all Universities.
- b. Perform the functions of Foreign Students advisor at Regional Office, Quetta.
- c. To advise the HEC on the affairs of Foreign Students and coordinate activities in all Regional Offices.

6. Duties as Liaison Office

- a. To provide information on the program and projects of HEC to maintain Liaison with Institutions the Regional Offices and to the Head Office.
- b. To provide information on Higher Education in the Region.
- c. To assist the HEC in its publications and informational program.
- d. To facilitate the people in attestation of degrees and issuance of equivalence certificate
- 7. To perform such other duties/functions or may be assigned by the competent authority from time to time.

Activities of Regional Centre

In the previous year HEC Regional Centre Quetta carried out following activities:

1. Administrative Duties

a. Office Establishment

HEC Regional Centre Quetta was established on 3rd May 2009 at Balochistan University of Information Technology, Engineering and Management Sciences Takatu Campus Quetta. BUITEMS provided a office with the basic facilities for the commencement of its operations in the region. BUITEMS was located at distant from city and it was difficult to the public to get access. In this regard meetings were held with the Vice Chancellors of the regional Universities and Higher Education Commission Islamabad after quality research and consultation the premises of University Law College were proposed for establishment of HEC Regional Centre Quetta.

Inaugural Ceremony of Regional Centre Quetta

The newly designed and renovated office building of Higher Education Commission (HEC) Regional Centre Quetta was inaugurated by Nawab Zulfiqar Ali Magsi, Governor Balochistan and Chancellor University of Balochistan (UOB) on 16th December 2009. The office building has



been provided by the University of Balochistan in the premises of Law College Quetta Cantt which is well designed with cabins, and provided with all facilities. Dr. S.Sohail H.Naqvi (Executive Director, HEC) and Dr. Masoom Yasin Zai (Vice Chancellor UOB) also attended the ceremony

b. Material Distribution

On regular basis regional centre distribute the reading materials, journals, newsletters, library materials etc. to different Universities, Institutions, and Govt: Departments and individuals of the

Region for publicity or as by request. A case of Library updating of Sardar Bhadur Khan Women University was also sent to Islamabad.

c. Collection of Data

This task was required by the statistics division of higher education commission Islamabad from regional universities of the Province time to time. The required data remained pending for a long time.HEC Regional Centre Quetta took keen interest in the matter and its persistent efforts made it possible to timely deliver the data to the concerned divisions.

The Details of the Data collected is as under:

Collection of Education Budget Data from Education Department Government of Balochistan

The Education Budget data for the year 2008-09 and estimated budget data for the year 2009-10 were collected from Government of Balochistan Education Department and forwarded to the Finance division HEC Islamabad as requested.

ii. Collection of District Wise Population Data from Census Department

The Project (i.e. "Provision of Higher Education Opportunities for Students of Balochistan and FATA") Relevant data (i.e. District Wise Population) was collected from census department and forwarded to the Project Director FATA and Balochistan HEC Islamabad.

iii. Collection of Statistic Data 2004-05

The statistical data for the year 2004-05 were collected from 13 different departments of the University of Balochistan and forwarded to the concerned division.

iv. Collection of Departmental data from University of Balochistan

The statistical data for the year 2004-05 were collected from two departments of the University of Baluchistan (i.e. Botany and Gender Development Studies) and forwarded to the concerned division.

v. Collection of PHD Theses data from University of Balochistan

The Regional Centre Quetta collected PHD theses data from University of Balochistan and would be forwarded to the concerned division.

vi. Collection of National Internship Program Data

The Regional Centre Quetta started collection of Data from Universities of the region in this regard.

vii. Collection of Enrollment Data (2005 to 2009) about Tertiary Education Institutions

The Regional Centre Quetta collected required information from the Universities of the region with respect to their University Campuses, Constituent and Affiliated Colleges.

viii. Collection of National Internship Program Data

The Regional Centre Quetta started collection of Data from Universities of the region in this regard and processed it accordingly.

ix. Collection of Data about Number of Degrees Awarded (2006-2009) from Education Institutions of Region

The Regional Centre Quetta collected required information regarding number of Graduates produced by the Universities of the Region. It includes data from University Campuses, Constituent and Affiliated Colleges from 2005 to 2009). The task is still in process and will continue in next month as well.

x. Collection of Statistics Education Data (2008-2009)

The Regional Centre Quetta collected required information from the Bolan University of Medical and Health Sciences from all departments. The data has been sent to the concerned department.

xi. Collection of District wise Population data

This task was required by Project Director (Balochistan-FATA) higher education commission Islamabad. District wise population data of Balochistan province was collected from Population census organization, statistic division government of Balochistan Quetta.

d. Test/Interviews of Candidates for Different Posts in HEC

i. Conducted Interview for the Contingent based post for Regional Centre

Higher Education Commission Regional Centre Quetta arranged the Interviews of candidates for the Posts of Computer Operator, Attendant and Driver in July 2009.

ii. Conducted Interview for the Post of Network Engineer and Support Engineer

2. Academic Duties


ii. Organized Foundation Course 2009

iii. The main objective of the foundation courses is to provide the best Knowledge and

practices in the core areas English, Mathematics, Islamiat and Current Affairs require for the success in NTS test. The course provides maximum Orientation and guidance to the students for the forth coming NTS test. It also helps to equip the students with the basic Knowledge required to broaden their vision.



Pre and Post test were conducted for the purpose of evaluating the performance of students before and after the course. The details of the result are as under:

iv. NTS test conducted for Balochistan-FATA Scholarships

The Higher Education Commission in collaboration with NTS Office Quetta conducted test for HEC scholarships under the project "Provision of Higher Education Opportunities for Students of Balochistan and FATA" at Boys Scout Head Quarter, Haali Road Quetta on 23rd August 2009, at 2:30 pm. There were overall 122 Post graduate and 487 under graduate candidates appeared in the test.

v. Facilitate newly selected candidates for (Baluchistan-FATA)

The result of NTS test regarding the scholarships of Project Titled "Provision of Higher Education Opportunities in Baluchistan and FATA" were announced in the month of October. HEC Regional Centre Quetta provided supportive guidance to the newly selected candidates regarding the Documentation and coordination with HEC Islamabad.

- 6. Arrangement of a proper training and development program for the staff of Regional Centre so that to have a team of technically sound and professional staff.

It is therefore expected that HEC Islamabad would provide its full support regarding these problems and make the Regional Centre grow with confidence. It will also act as a motivational factor for the centre to perform better in the future.
