









Key Dimensions of International Quality Requirements



Textiles

- Regulatory (safety, labeling, origin or other).
- Product specific (durability, performance appearance), customer specific (physical, chemical, or other).
- Social (labor, facility and work environment).
- Environmental (water treatment, solid waste, recycling, energy conservation).

Key Dimensions of International Quality Requirements

Rice

- Rice quality factors include: general, specific, contaminants, hygiene, packaging, and labeling related requirements.
- For consumers:

Quality encompasses a complete range of visual, sensory and palatability criteria that include impressive appearance of raw as well as cooked rice texture in terms of stickiness/flakiness and appealing aroma".



Major Issues and Gaps of Textile Sector

Lahore School of Economics

- Lack of quality orientation and commitment.
- Poor in-process handling.
- Consistency in product quality.
- Quality pattern making and stitching capabilities exist.
- Labor development and human resource development.
- High quality raw materials and inputs.
- Packaging material quality and labeling (barcodes, RFID, etc.) related issues.
- ▶ IT infrastructure such as ERP and EDI at supplier level.
- Law and order situation.

Major Issues and Gaps of Rice Sector

- Research in grain development & new varieties.
- Poor handling of pre-harvest and post-harvest paddy.
- Accredited local testing facilities for critical lab testing.
- Control of QRC.
- Quality and compliance orientation at grower level.
- Effective body representing the interest of the whole supply chain.


Inspection Criteria for Rice

- Percentage of moisture.
- Broken grains (checked through grain scanners).
- Purity level.
- Basmati and non-basmati mixing (DNA).
- Shriveled (immature grain).
- Damaged grain (discolored, field damage, fungus and foreign content like insects, stones etc.).
- Red rice.
- Tip breakage.
- Whiteness (under milled).
- Average grain length (AGL).

Lahore School of Economics

Textile Sector

- Invest in R&D of cotton crop.
- Invest in human resource development at all levels.
- ▶ Joint ventures with technically advanced and mature players such as China, Sri Lanka and Turkey.
- Government should facilitate and encourage hiring, training and development of women for garments and knitwear production.

Textile Sector

- ▶ Facilitate travel of foreign buyers.
- Big players across different sectors of industry can come forward to form strategic partnership (holding companies) to reach a certain size / scale of operations comparable to regional competitors.
- Effective public private partnership to improve Pakistan's image.
- Introduction of a national quality award in Pakistan along the lines of Malcolm Baldrige National Quality Award in the US.



Rice Sector

- Focus on result oriented R&D in grain development and new varieties of rice.
- Enactment of law.
- Government should offer soft loans.
- Need for globally recognized accreditations for national and local testing and inspection facilities.
- QRC (Quality Review Committee) should be an independent body instead of being under control of TDAP (Trade Development Authority of Pakistan).

Policy Recommendations

School of Economics

Rice Sector

- For pre-shipment inspections, third party recognized names such as SGS. should be added to the approved service provider list in addition to QRC.
- Government should encourage export of <u>branded rice</u> by offering soft loans and other incentives.
- Establishment of an <u>effective body</u> representing the interest of the <u>whole sector</u> with global reach that can facilitate research and development of new varieties, registration of new varieties, work in coordination with public sector to improve awareness at farmer level, and contribute towards formulation of a comprehensive code of conduct and/or regulations for the entire supply chain within the rice sector.
